



**TOWN OF BLACKFALDS  
BYLAW 1107/10**

A BY-LAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE TOWN OF BLACKFALDS FOR THE 2010 TAXATION YEAR.

WHEREAS the Town of Blackfalds has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the Council meeting held December 8, 2009.

WHEREAS the estimated municipal expenditures and transfers set out in the budget for the Town of Blackfalds for 2010 totalling \$ 11,494,274

WHEREAS the estimated municipal revenues and transfers from all sources other than taxation are estimated at:

\$ 5,141,274	Minus Total Funding from Other Sources
\$ 1,263,000	Minus Total Requisition Funding
\$ 50,000	Minus Expected Supplemental Taxes
<b>\$ 5,040,000</b>	<b>Municipal Property Taxes</b>

WHEREAS the Town of Blackfalds, as per the annexation agreement, shall be authorized to levy taxation rates against the annexed lands as per the Lacombe County taxation rates of 2010.

WHEREAS the Council is authorized to classify assessed property and to assess rates of taxation as per the Lacombe County hereby covered under the annexation approval conditions

WHEREAS the requisitions are:

WHEREAS the Council of the Town of Blackfalds is required each year to levy on the assessed value of all property tax rates sufficient to meet the estimated expenditures and the requisitions; and

WHEREAS the Council is authorized to classify assessed property and to establish different rates of taxation in respect to each class of property subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2000; and

WHEREAS the assessed values of all taxable property in the Town of Blackfalds as shown on the assessment roll is \$703,592,570.

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the Municipality of Alberta, in the Province of Alberta, enacts as follows:



The Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property as shown on the assessment roll of the Town of Blackfalds.


